

Privacy Policy

(updated on 29th August, 2022)

Publicprocurement.in is committed to protecting and preserving the privacy of our visitors when visiting our site or communicating electronically with us.

This policy sets out how we process any personal data we collect from Users or that Users provide to us through our website. We confirm that we will keep Users information secure and that we will comply fully with all applicable Data Protection legislation and regulations. Please read the following carefully to understand what happens to personal data that Users choose to provide to us, or that we collect from Users when Users visit this site. By visiting Publicprocurement.in Users are accepting and consenting to the practices described in this policy.

Types of information we may collect from Users

We may collect, store and use the following kinds of personal information about individuals who visit and use our website:

Information Users supply to us. Users may supply us with information about Users by filling in forms on our website. This includes information Users provide when Users submit a contact/enquiry form *[list any other active forms on the website (i.e., Request Signup, other Forms etc.)*. The information Users give us may include User name, office name & address, e-mail address and phone number, *etc.*)

Information our website automatically collects about Users. With regard to each of Users visits to our website we may automatically collect information including the following:

- **technical information**, including Users' Internet protocol (IP) address, browser type and version, operating system and platform;
- **information about Users visit**, including what pages Users visit, how long Users are on the site, how Users got to the site (including date and time); page response times, length of visit, what Users click on, documents downloaded and download errors.

- **Information collected through third party services for marketing or SEO services**

Cookies

Our website uses cookies to distinguish Users from other users of our website. This helps us to provide Users with a good experience when Users browse our website and also allows us to improve our site.

How we may use the information we collect

We use the information in the following ways:

Information Users supply to us. We will use this information:

- to provide Users with information and/or services that Users request from us;

Information we may automatically collect about Users. We will use this information:

- to administer our site including troubleshooting and statistical purposes;
- to improve our site to ensure that content is presented in the most effective manner for Users and for Users' computer;
- security and debugging as part of our efforts to keep our site safe and secure.

This information is collected anonymously and is not linked to information that identifies User as an individual. We may use Google Analytics to track this information.

Disclosure of Users' information

Any information Users provide to us will either be emailed directly to us or may be stored on a secure server of a trusted third party website and hosting provider to facilitate the running and management of this website. This provider meets high data protection and security standards and is bound to keep any information they process on our behalf, confidential.

We do not rent, sell or share personal information about Users with other people or organisations. We will use all reasonable efforts to ensure that Users' personal data is not disclosed to regional/national institutions and authorities, unless required by law or other regulations.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect Users' personal data, we cannot guarantee the security of Users' data transmitted to our site; any transmission is at Users' own risk. Once we have received Users' information, we will use strict procedures and security features to try to prevent unauthorised access.
